BENGAL GLOBAL BUSINESS SUMMIT 2017

PRESS RELEASE

The third edition of Bengal Global Business Summit 2017 was held on 20th and 21st of Jan 2017 at Milan Melan Mela Grounds, Kolkata in keeping with the theme of *"Come to Bengal, Ride the Growth."* The event has grown in size and stature attracting participation by delegates from across India and 29 countries. This underlined the primacy of West Bengal as an attractive investment destination and reflected the progressive policy regime of the government of West Bengal.

A total of **Rs.2,35,290.03 Crore** of business announcements, business document exchanges, expressions of interest and investment proposals were received at the two day Summit. A sector wise abstract is given below:

Russian business and trade delegation exhibited some of their products and exchanged business interests. Commemorating the 10th anniversary of sister city cooperation, a special session on Ubiquitous City of Incheon was held on Day 1.

ASEAN business development session on "Rising Bengal in Emerging Asia"; session on clothing and apparel and special country sessions were held on Day 2.

Apart from B2G meetings, 425 B2B meetings took place and continued post the closing plenary session.
